Good Afternoon Friends,

In addition to the information in the message sent to you at your work email, we've included information below on a variety of topics. But before we get to that, I wanted to clear up some information that I have heard circulating.

My understanding is that there is information being communicated around what teachers can (or can't) say or how they can (or can't) express themselves concerning the recently released draft curriculum.

First and foremost, you have a fiduciary responsibility to your employer (Edmonton School Division). Which means (in essence) that you should not be criticizing them in a public or in public forums. How does this relate to the draft? Technically it doesn't, but we wanted to make sure that people understood this.

Now, related to the government and curriculum.

In addition to being a teacher, you are also a tax-paying private citizen that elects members of government to represent you and your constituency.

Not only do you have a right, but in my opinion, also a responsibility to speak out against any level of government that you believe to be making decisions that are not in the public interest. Or, in this case not in the best interests of our students.

Organizing petitions, peaceful protests & demonstrations, speaking at rallies, getting lawn signs, calling/writing government members, or giving a personal opinion in an interview are all ways that you can, and are allowed to, make a difference.

There are only two cautions I give.

1. Please do so respectfully and rationally, remember that we represent teachers and the profession 24-7, and we are **always bound by the Code**.
2. If speaking to media, be clear that you are expressing **your own personal opinion**. Not that of all Alberta teachers, nor that of your Board.  
(Please don't hesitate to reach out to myself as Local President or provincial President Jason Schilling if you are contacted by media.)

One last reminder... please remember that you have colleagues that have been seconded to Alberta Education. Many of them had to "review" the draft. However, all of them had to sign confidentiality agreements. We don't know what (if any) of their feedback was actually used (or ignored). We do know the Advisory Panel had unprecedented access and decision making authorization. I do know after having some conversations with a few of them that they are feeling the same frustrations and anger you are. This is not the curriculum that they wanted, or signed-on to be a part of.

I think we can all agree that our anger, frustration, and criticism is directed solely towards the government in this regard.

With that all said, if you are told anything contrary to what I have said in regards to your freedom to speak against this draft, please don't hesitate to call the Local or to ask them to call the Local for clarification.

We are in this together, and together we are stronger (and louder).

Hi everyone,

Many of you know that the AB government recently released a draft curriculum for K-6. Many of you have probably already looked at it all or parts of it and understand what all the fuss is about (and there has been A LOT of fuss). You can find it [here](#). Please consider taking a look at the information below and getting involved. We are all maxed out and have little, if any energy, but it is so important that the government hears as many voices as possible. This draft curriculum will affect every one of us. Please feel free to forward this email, including family and friends outside of the school system!

As of today, there are **29** Alberta school boards who have said they will not pilot the draft curriculum, including Edmonton Public. Many organizations have expressed their serious concerns with the draft, including but not limited to:

- Alberta Teachers Association
- The Métis Nation of Alberta
- The Confederacy of the Treaty No. 6 First Nations Chiefs
- AB French Canadian Association
- Canadian Teachers Association
- Black Teachers Association

The Minister of Education stated that there would be **public town halls** during April, but I have not heard of any yet. If you know when/where to get the link, please share and then voice your thoughts!

The Alberta Teachers' Association is calling for the Government of Alberta to stop all work on the piloting and implementation of the draft curriculum until an independent, open and full review and rewrite can occur. The Association published full-page ads in daily newspapers across Alberta to issue the **call for a moratorium** and to show support for school boards and teachers that decide not to participate in piloting.

Did you know that "[p]reliminary results from an extensive survey [by the ATA] on the draft curriculum show that **91 per cent** of teachers are unhappy with the draft, including 3 in 4 teachers stating they are "very unhappy." The curriculum evaluation project launched by the Alberta Teachers' Association shows that **90 per cent** of elementary school teachers are uncomfortable teaching the new K-6 curriculum, and **95 per cent** of principals are uncomfortable supporting the curriculum in their school and community."
